IWINYOULOSE was steadied along while lacking room along the rail behind the leaders on the first turn and onto the backstretch, came out between horses for room, moved to vie from the outside on the final turn then drew out under mild urging. PRIME TIME TICKET cleared then angled to the inside shortly after the break, remained in control to early stretch then weakened. HAY BUSY BANDIT was unhurried early, advanced the rail on the final turn then continued evenly through the lane. SIMPLY STYLIN was caught wide into the first turn, angled to the inside on the final turn and made up some ground in the lane. THE REIGN FALLS lagged then passed tired ones. JUSTA SURVIVOR showed early speed inside then stopped. LEGALISH was outrun. SUMMATION showed early speed then stopped. SAXON WARRIOR was finished early.
